- 3. The **sealed envelope** should be marked "BID ON SURPLUS UNFPA APRO ASSET" and dropped in the BID BOX specifically placed for this purpose at UNFPA APRO 4th floor Services Building, Rajdamnern Nok Avenue, Bangkok.
- 4. The sale of the office assets is on "AS IS, WHERE IS" basis.
- 5. Bid Forms is accepted only at UNFPA APRO office until **15:00 hours of Tuesday, 6 November 2018**.
- 6. Bids will be opened on Tuesday, 6 November at 15.30 Hours. The bidder tendering the highest price is awarded the sale.
